

# WILLOWPOOL CAULDRON FISHINGS

## CONDITIONS OF LET SEASON 2019

**DESCRIPTION** The fishings are as follows:

### **Weekly lets from 1st September to 31st October (Party 6)**

One named day a week let from 1st April to 31st October 2019 (Full Season) (Party 5)

One named day a week let from 1st April to 31st August 2019 (Sea Trout Season) (Party 6)

**WILLOW POOL** Mainly single bank from a point about 155 metres upstream of the junction of the Rivers Esk and Liddle to the confluence with the Boughlin Burn and the Bridge, a distance of 640 metres. The beat includes the Willow Pool at the junction of the two rivers and Bells Weir above the Willow Pool.

**CAULDRON BEAT** Single bank from the confluence of the Boughlin Burn to the national border, a distance of about 1189 metres. The beat includes the Cauldron Pool and run, the Cobbles and the Barr stream.

**RODS** Each party is for a **maximum of three individual rods** for the duration shown on the attached schedule. For the avoidance of doubt, it is not acceptable that more than three people should share the daily allocation of three rods.

### **ROTATION (Party 5/6) Willow Pool/Cauldron Beats**

Weekly lets from 1st September 2019. Rods will fish the beat first allocated from **Monday** through to 06.00 hours **Tuesday** when they will rotate to the opposite beat and change thereafter at 06.00 daily. Weekly 3 rod lets (Party 6) will be allocated Hut 6.

The attached Rotation sheet highlights which beat you are fishing on your respective day (days) and the hut allocated. Party 5 - Hut 5. Party 6 - Hut 6. Day rods will rotate each alternative week between Willow Pool and Cauldron beats.

### **SHARING THE WATER**

Rods are expected to treat other rods fishing the beat with great consideration and to move down the water taking a minimum of one step per cast. When fishing a single bank, rods should not enter the water directly in front of those fishing the opposite bank but enter upstream. Should the person opposite fail to move down then the rod may proceed downstream.

### **RESERVATIONS**

1. In the event of beats remaining unlet, the fishings reserve the right to let individual rods by the day.
2. At all times the fishings reserves the right to permit two extra house rods to fish any beat.

### **RESTRICTIONS**

1. Tenants will comply with all legal requirements including the By-Laws made by the Environment Agency affecting the River Esk in Scotland. Rod Licences are not generally required in Scotland, however the Environment Agency state that they will enforce English/Welsh type Rod Licence on as much of the Border Esk and its tributaries as are situated in **Scotland** as from 1st April 2005.

2. **SEASONS**     **Salmon**     **1st April to 31st October**  
                         **Sea Trout**     **1st April to 30th September**

### **ACCESS**

Rods must use the car park and access points.

### **TRANSFER OF RODS**

Tenants will be permitted to transfer permits to a friend/relative, **but any transfer must be for a full day to an individual.** Tenants must ensure that all those fishing are fully instructed in regard to the boundaries and all other Conditions of Let.

### **FISHING HUTS**

#### **WEEKLY LETS (Party 6) September – October**

The hut will be unlocked ready for weekly parties and keys left within for their use and retention during the week. Guests are invited to go direct to the Beats. At the end of the fishing week guests may leave keys in the catch return book or, if they wish, return them to Peter Kinstry the Water Bailiff.

#### **DAY-A-WEEK LETS**

#### **(Party 5 Full Season, Party 6 Sea Trout/Grilse)**

Rods will normally be issued with a key for the duration of the let.

### **GHILLIE**

There is no permanent Ghillie on the private beats.

### **CATCH RECORDS**

In each fishing hut there is a sheet for recording the numbers, the weight of fish caught. **Tenants are required to fully complete this sheet ON A DAILY BASIS.**

### **HEALTH AND SAFETY ACT**

The Willow Pool and Cauldron Fishings accept no responsibility for injury or loss incurred by rod holders or damage caused to vehicles, fishing tackle or other property belonging to the rod holders or others arising from their let. Anglers are particularly warned of the dangers of electric fencing erected by local farmers. All rods must accept the risk incidental to the exercise of the right of fishing thereby conferred, and will have no claims against the Willow Pool and Cauldron fishings for any injury, loss or damage suffered by them in consequence thereof. Weak and non-swimmers are advised to wear a buoyancy aid.
